

# Damage Waiver

In consideration of the undersigned being permitted to take part in this Driver Development program, I agree:

A) That JE-CO Motorsports, its instructors and personnel shall have the right at any time, which they in their sole and absolute discretion may see fit, to cancel my enrollment/participation in the Program, either before, after, or during any particular lesson or stage, for any reason whatsoever and without giving cause, and in such event I shall be obligated to pay for only those lessons taken by me up to such time.

B) To release, remise and forever discharge and to indemnify and hold harmless JE-CO Motorsports; JE-CO Motorsports; their owners, respective staff, students, instructors, officers, directors, shareholders, invitees, employees, agents and representatives from and against any and all actions, claims, costs, expenses (including attorney's fees) or demands of any and all kind whatsoever, including without limitations, those in respect of death, injury, loss, or damage to any person or property of myself, any other driver, student, passenger, mechanic, invitee, teacher, school, person, track, car or vehicle or otherwise however caused, arising directly or indirectly, out of or in connection with this Application by me or my taking part in or participating in JE-CO Motorsports Driver Development, notwithstanding same may arise out of or be claimed to arise out of the negligence of said parties, their owners, respective staff, instructors, servants, representatives, agents, directors, officers, shareholders or invitees.

I expressly acknowledge that I realize the seriousness of these programs, the safety precautions necessitated by JE-CO Motorsports, the nature of the activities therein involved and the risk related thereto and state that I do not now nor have I had in the past ten years any defect, physical or mental, which could in any way impair my driving or driving ability. I declare that as a driver applicant I possess the standard competence necessary for a program of this type. I undertake to abide meticulously by each and every one of the rules and regulations, to perform the Driver Development Program exactly as set forth and given to me by the instructors and acknowledge that in the event I should deviate from said curriculum and instructions, that I may at the discretion of JE-CO Motorsports be removed from further participation in said activities and shall be held responsible for the payment of any and all damages whatsoever caused by my conduct.

I acknowledge that the deductible schedule for those who have successfully completed all prerequisite programs is as follows and that I may be required to post a negotiable security deposit prior to beginning any program:

- Deductible for graduates of the Techniques Course  
\$3,500.00 1<sup>st</sup> Accident, \$6,500.00 2<sup>nd</sup> Accident, Unlimited 3<sup>rd</sup> Accident
- Deductible for graduates of other accepted racing schools  
\$6,500.00 1<sup>st</sup> Accident, Unlimited 2<sup>nd</sup> & 3<sup>rd</sup> Accident

For all racing programs, I acknowledge that the deductible amount for those who have not completed any and all prerequisite school programs is 100% and that a negotiable security deposit of \$3,000.00 shall be required prior to beginning any program. I further acknowledge that company policy is such that if I exceed 80% of the deductible I will be bumped to the next higher level prior to my next driving exercise. I furthermore expressly acknowledge that if any term, provision or condition of the foregoing is held for any reason to be invalid, void or unenforceable, that the remainder of the provisions above shall nonetheless remain in full force and effect. I have read the foregoing waiver indemnification and release and further know and understand the significance thereof and acknowledge that no officer, agent or employee of the school or the track as the case may be is authorized to vary the terms or provisions of this document or to make any representations contrary to provisions set forth above. Additionally, I agree to allow JE-CO Motorsports to use my name and any photos of me for the purposes of promoting the Driver Development Program without restriction.
