

## MINORITY RELEASE AGREEMENT

WHEREAS, I \_\_\_\_\_, of minority age, and I, \_\_\_\_\_ legal parent/ guardian to \_\_\_\_\_, have requested of JE-CO Motorsports whose principle office is located in Denver, CO permission to enroll \_\_\_\_\_ in a Driver Development Program of racing instruction and provide a race training program, and any other related form of racing related activity incidental to the course of racing instruction, AND WHEREAS, I have been explicitly advised of the potential risks and hazards involved in a Driver Development Program and general racing in particular, and whereas I have been fully and completely advised prior to executing this agreement that a Driver Development training program, and any other related form of racing related activity incidental to the course of racing instruction, general racing, involves a high degree of risk and the possibility of property damage and serious personal injury and hazards to \_\_\_\_\_ and others, including but not limited to the possibility of death, which is inherent in the Auto Racing Industry inclusive of race training, racing competition activity, or racing in general, and having been fully informed of these hazards and risks, including the possibility of death, and fully and completely comprehending and understanding same, I still desire permission to commence a Driver Development Program of racing instruction and have JE-CO Motorsports provide \_\_\_\_\_ with a race training program, and any other related form of race related activity incidental to the course of race instruction necessary for a race training program, or engage in general racing using JE-CO Motorsports facilities, racecars and equipment. AND WHEREAS, it is the purpose of this Agreement to release, JE-CO Motorsports, its directors, officers, shareholders, employees, agents, representatives, successors and assigns, any owner or owners of racecars leased or operated by or on behalf of JE-CO Motorsports from any and all liability for all personal injuries and property damage that may occur during the course of race instruction, or any other race related activity, and to assume the risks of the above related racing activities. NOW THEREFORE, the undersigned, in order to induce JE-CO Motorsports to provide race training I hereby: (1) assume all the risks and hazards attendant with any race training, race related activity, or racing in general (2) forever release JE-CO Motorsports it's directors, officers, shareholders, employees, agents, representatives, successors and assigns, and any owner or owners of race cars leased or operated by or on behalf of JE-CO Motorsports from and against any and all causes of actions, claims, rights or demands which I, \_\_\_\_\_, or my heirs, or relatives, executors, administrators and assigns can or might have as a result of any loss, damages, expenses and personal injury, death, or property damage which I, \_\_\_\_\_, or any person may suffer or sustain, in law or in equity and (3) agree to indemnify and hold harmless JE-CO Motorsports its directors, officers, shareholders, employees, agents representatives, successors or assigns, and any owner or owners of racecars leased or operated by or on behalf of JE-CO Motorsports from and against any and all claims, damages, losses and expenses, suits, and judgments, including but not limited to those attorney fees and disbursements, however caused, including but not limited to those for property damage, bodily injury including death, arising out of or in connection with any and all race training, racing in general, use and/or maintenance of any race cars, racing related activities, any racing conditions and/or the performance, nonperformance, breach or alleged breach of any representations or obligations of JE-CO Motorsports it's directors, officers, shareholders, employees, agents, representatives, successors and assigns, or any owner or owners of race cars leased or operated by or on behalf of JE-CO Motorsports provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, including loss of use there from, regardless of whether or not caused in part by a party indemnified hereunder. Such obligation shall not be construed to negate, abridge, or otherwise reduce any other right or obligation of indemnity that would otherwise exist as to any party or person described in this paragraph.
